of a Business E-Mail Compromise scam that took place in December 2016 but was not discovered until January 2017, resulting in the loss of approximately \$242,000 via an electronic transfer of funds to an overseas account. Our Revolution worked with the Federal Bureau of Investigation, Our Revolution's counsel and an independent cyber-security consultant in an effort to identify the thieves and to recover the funds but, unfortunately, these efforts were unsuccessful. Following this incident, working with the independent cyber-security consultant, Our Revolution continues to put into place additional safeguards, including both technical and human security measures, procedures and protocols.
