Fix the Court is a nonpartisan, 501(c)(3) organization that educates the American people about, and advocates for, non-ideological "fixes" that would make the federal courts, and primarily the U.S. Supreme Court, more modern, more open and more accountable.

 Legal: Fix the Court, via an attorney known for his FOIA work, sued the U.S. Marshals Service (a division of USDOJ) over an unanswered FOIA request regarding travel undertaken by the justices of the U.S. Supreme Court from early 2018 through late 2022 that may not have been reported to the public. The litigation is ongoing, but Fix the Court expects the USMS to produce all responsive documents, about 5,000 pages worth, by the end of 2023.

4b (Code:) (Expenses \$ 448 including grants of \$) (Revenue \$)
 Media: It is critical that Fix the Court keep up with any and all news about the federal judiciary, so the organization subscribes to many online news sources in order to do that, which helps the organization pitch these news sources stories about judicial modernization that could help with its mission. Fix the Court is frequently featured in broadcast, print and online news stories about the judiciary's opacity and efforts to bring it in to the 21st century.

 Federal court records fees: Fix the Court advocates for public access to PACER, the federal judiciary records system, to be free and not cost the public \$0.10 per page to read court documents. In order to better understand dockets and workflow on PACER, and to stay abreast of critical court cases throughout the country, Fix the Court downloads hundreds of pages of documents per quarter.
